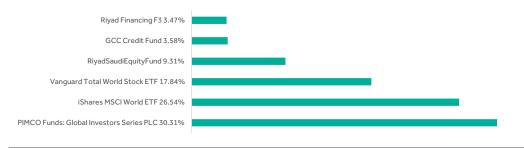

Fund Investment Objective

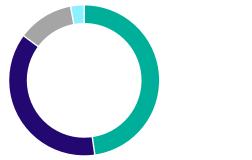
