Fund Investment Objective

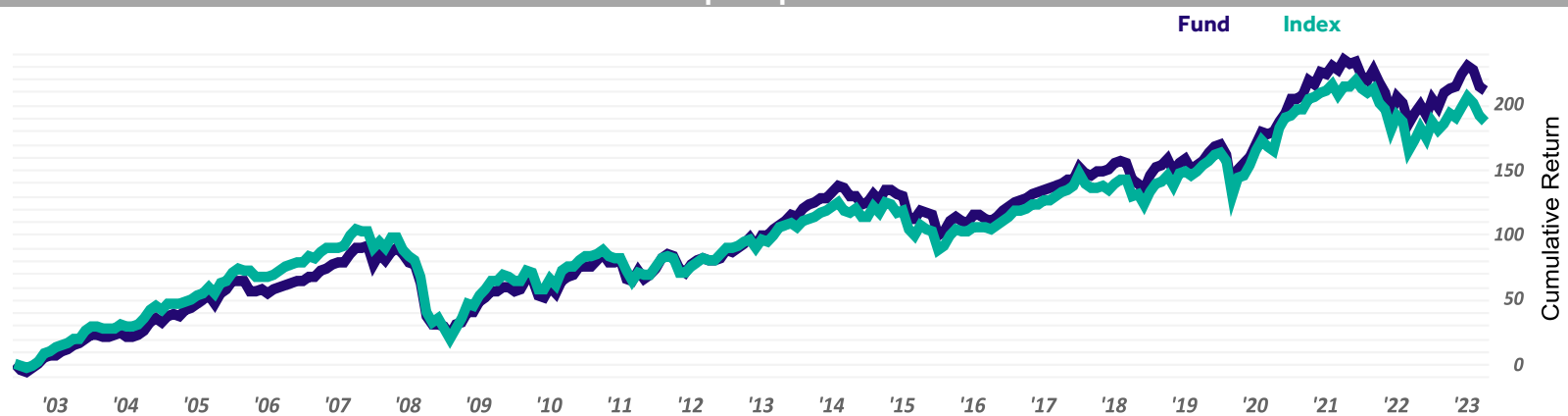

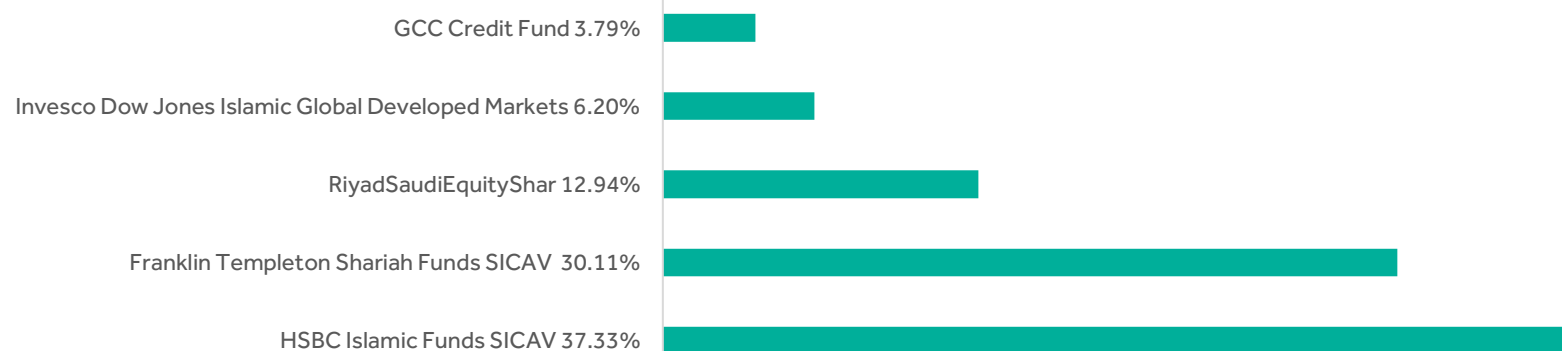
