

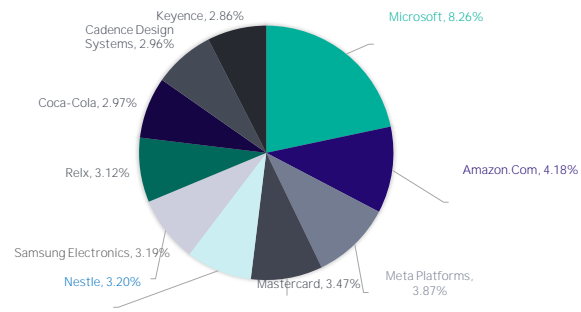

ASSET DISTRIBUTION BY GEOGRAPHICAL

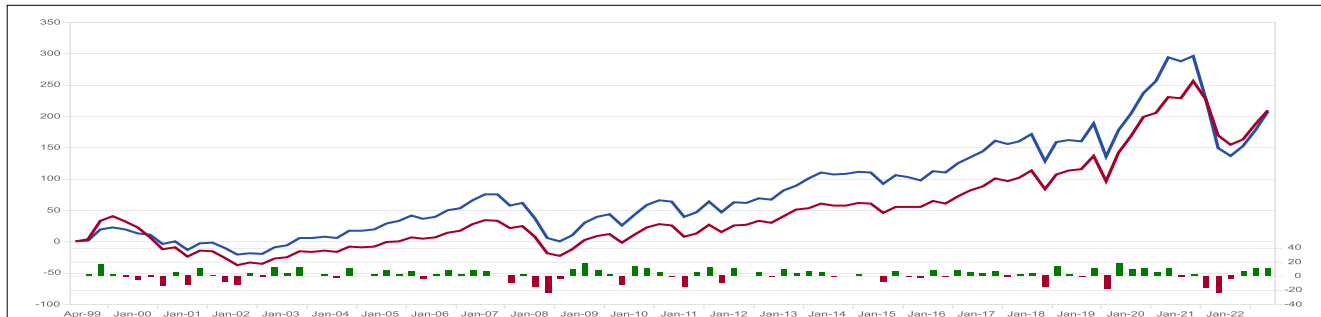
