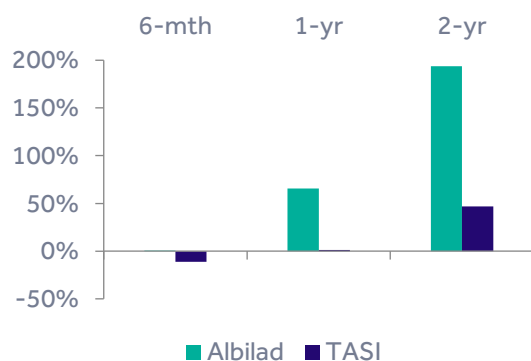

- Bank Albilad maintained its consistent growth in net financing, growing by SAR 1.1 bln Q/Q. Similarly, deposits continued to grow for the third quarter in a row, adding SAR 4.8 bln Q/Q.
- Return on deposits and financial liabilities jumped by +301% Y/Y and +68% Q/Q. However, Income from Investing and Financing assets have also improved, resulting in higher Net Investing and Financing Income by +13% Y/Y and +5% Q/Q to reach SAR 1.0 bln.
- Non-core income increased on a yearly basis by +12% to SAR 322 mln, driven by higher other operating income, net exchange income and net gains on FVSI investment. Therefore, total operating income increased on both yearly and quarterly basis by +13% and +6%, respectively, to SAR 1.3 bln.
- Total operating expenses have increased by +7% Y/Y to reach SAR 723 mln due to an increase in other G&A, salaries and depreciation & amortization.
- Bank Albilad reported a net income of SAR 541 mln (up by +20% Y/Y and +6% Q/Q), matching our SAR 543 forecast. We maintain our target price and rating.
