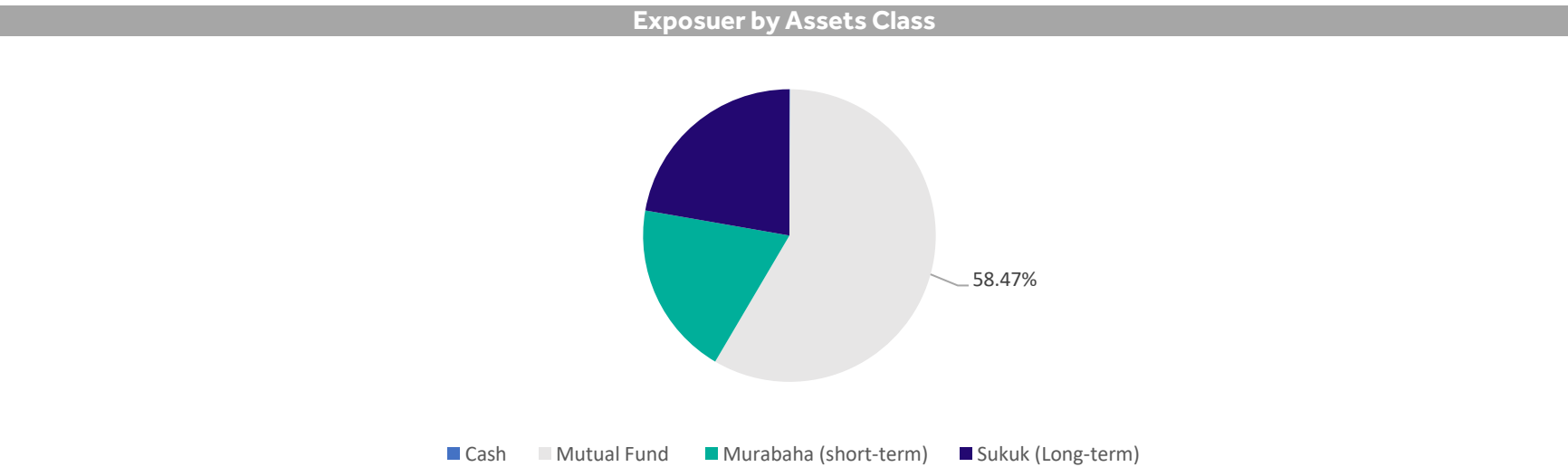
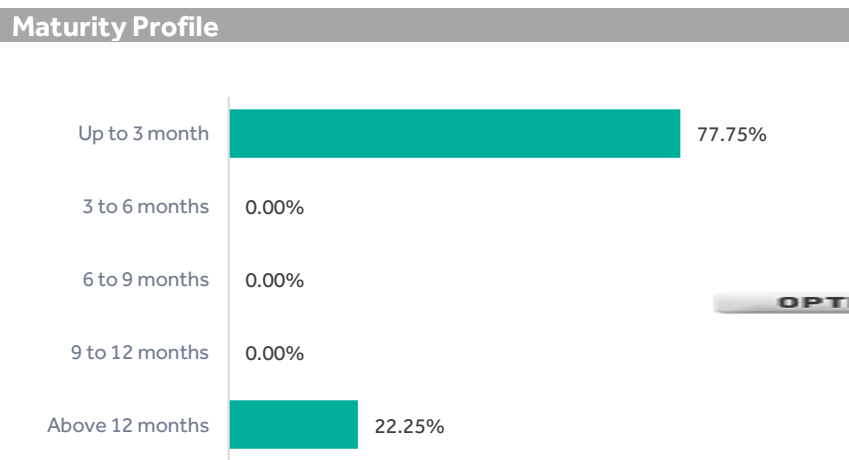
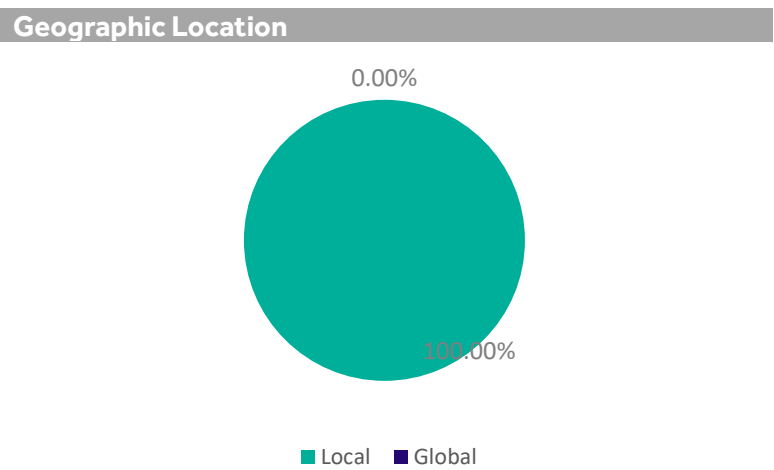
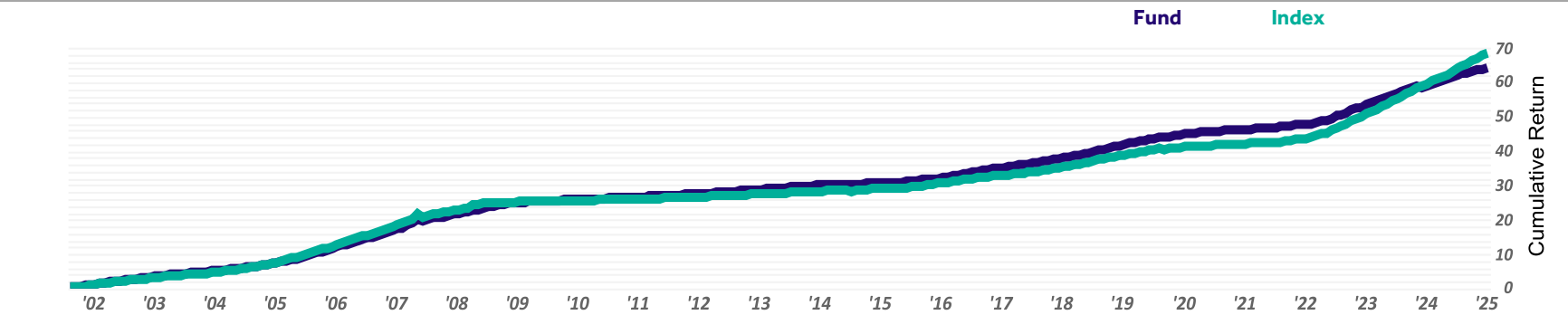


**Fund Investment Objective**
