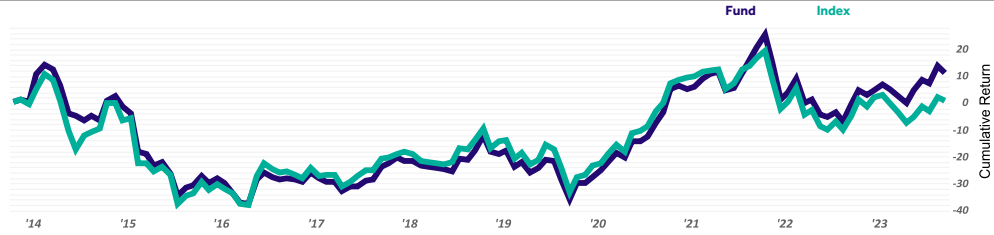
## Fund Investment Objective

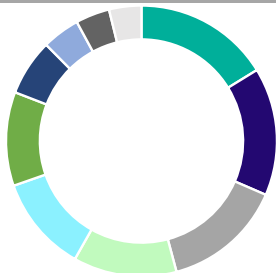
