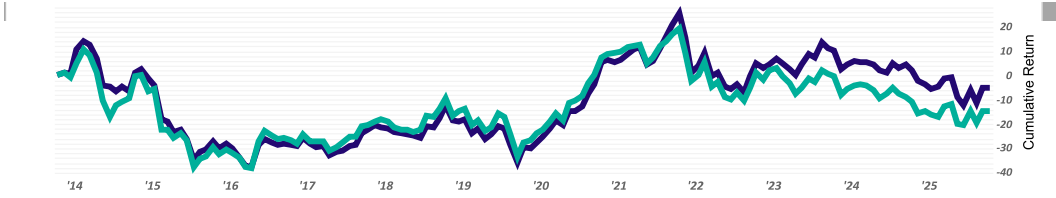


Fund Investment Objective
