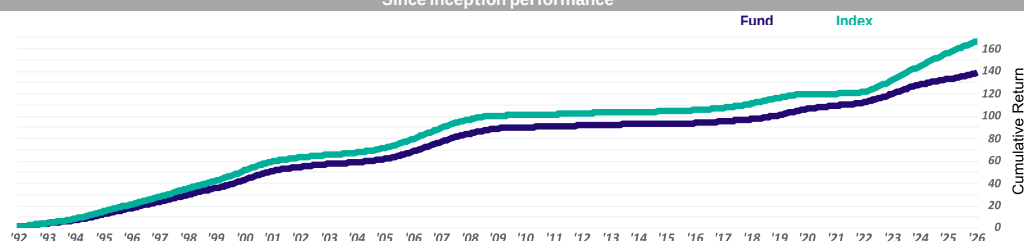

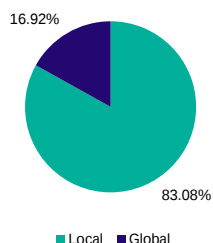

Since inception performance



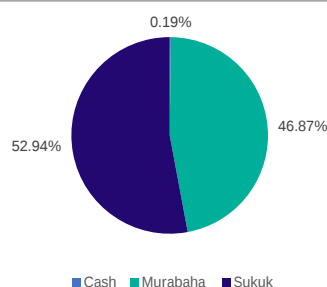
Geographic Allocation
