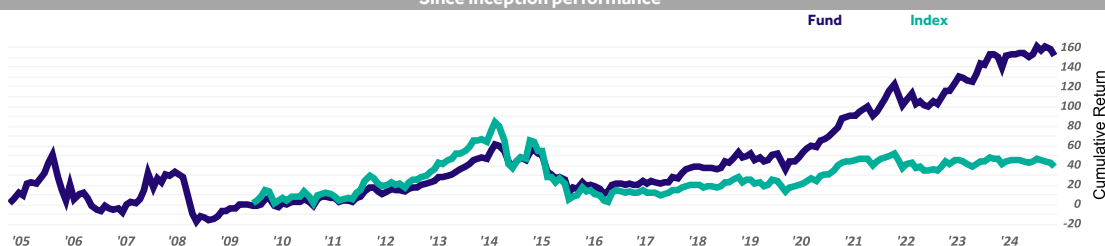
Fund Investment Objective

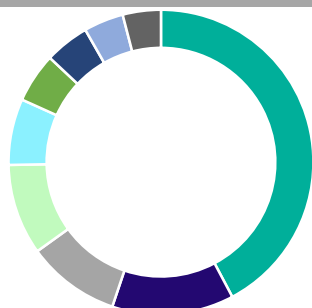
