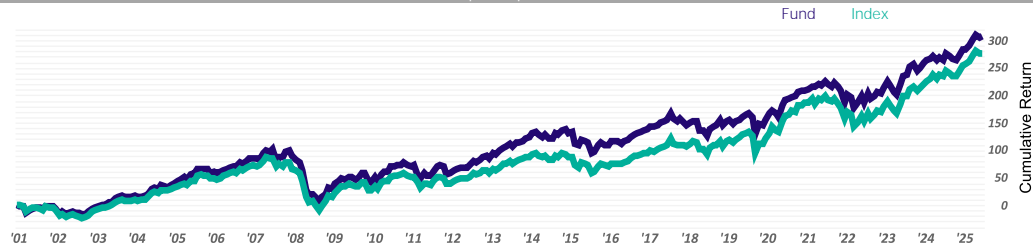
## Fund Investment Objective
