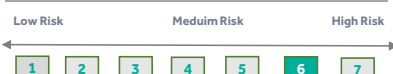

Fund Investment Objective

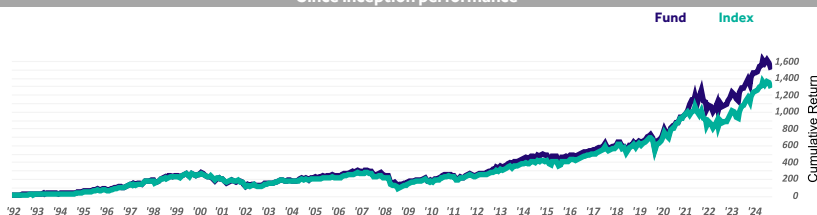

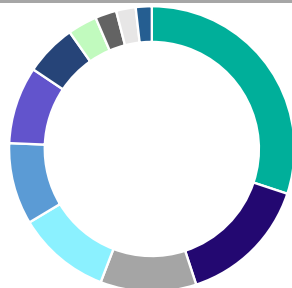
