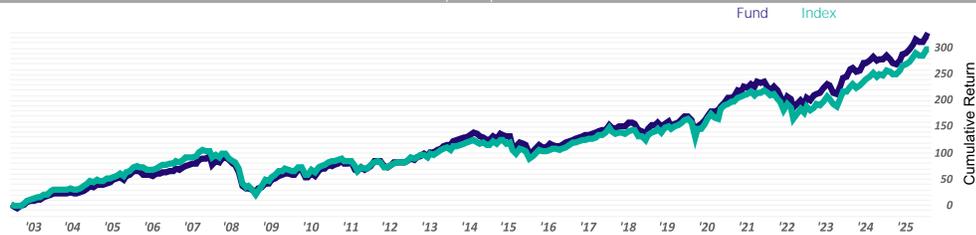

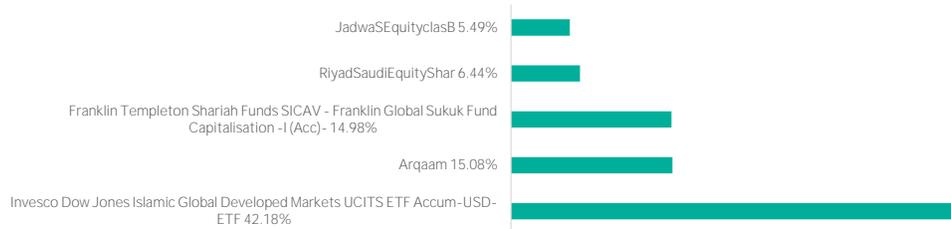

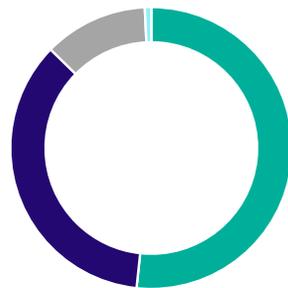
## Since inception performance
