



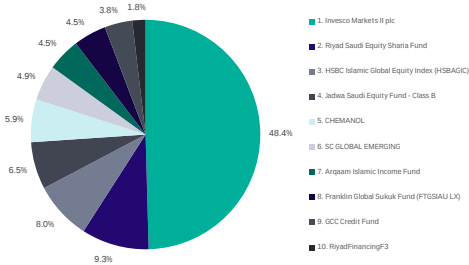
Fund Objective

It is a general open-ended fund that invests in a group of funds that are compatible with Shariah standards approved by the Shariah Committee. It aims at long-term capital growth under high risks.

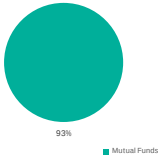

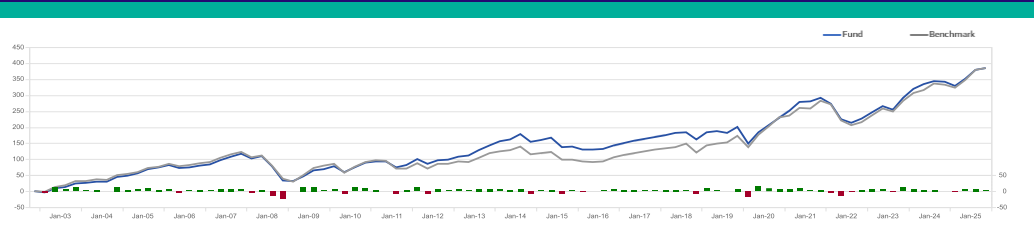
