Definitions

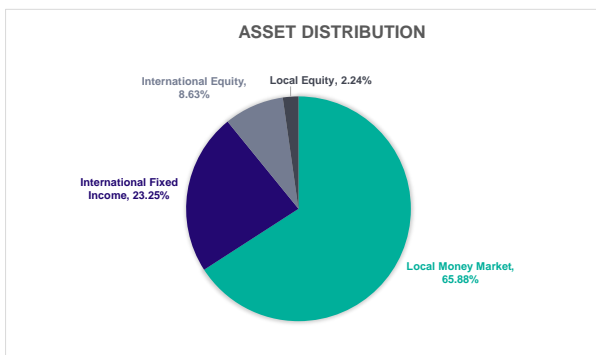
Standard Deviation	Most of the time the fund's monthly average return will fluctuate, at least, by this number

Information Ratio	The risk adjusted Excess return, shows manager's skill

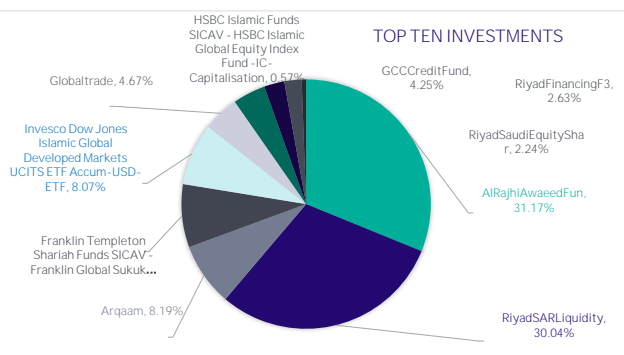

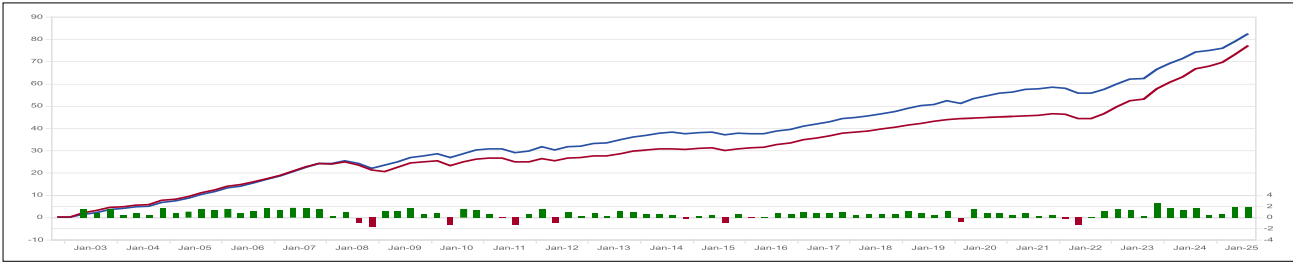
