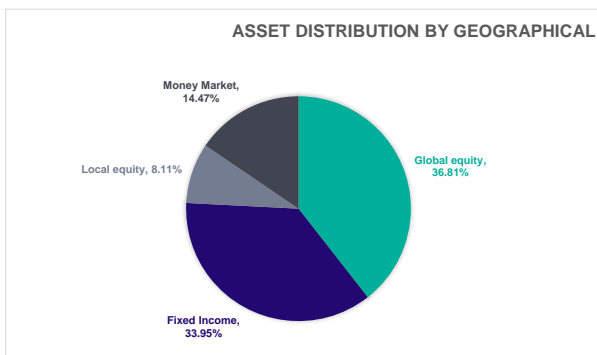
Standard Deviation	Most of the time the fund's monthly average return will fluctuate, at least, by this number

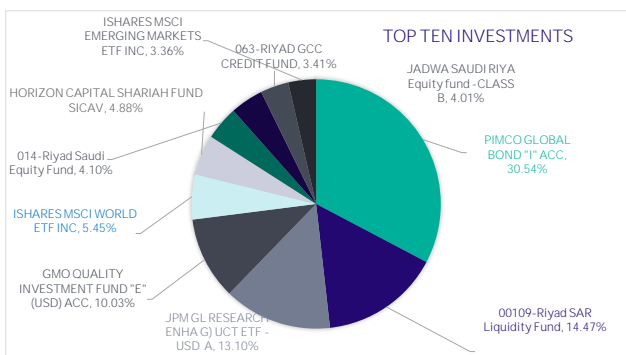
