



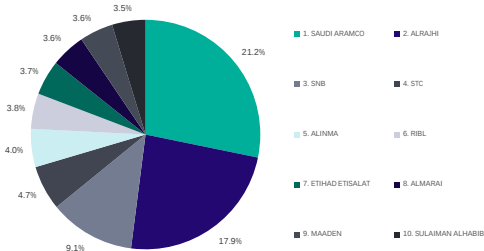

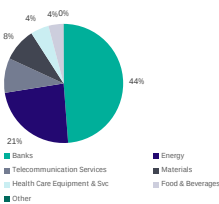

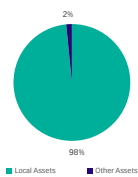

Cumulative Returns (%)

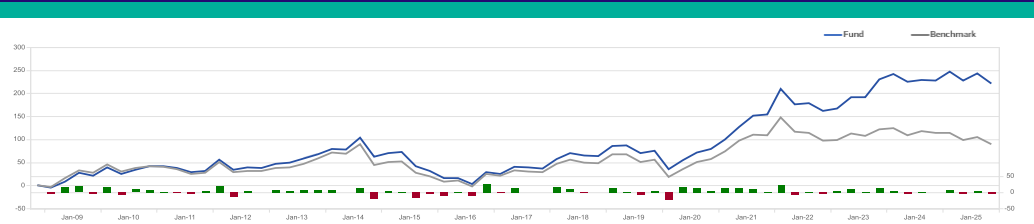
