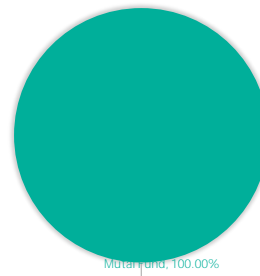

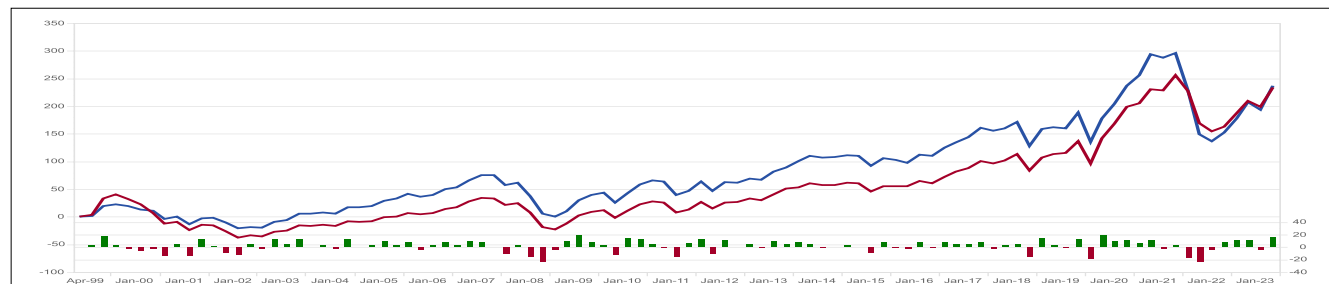
ASSET DISTRIBUTION BY GEOGRAPHICAL
