



# **CONSENT NOTICE**

Riyad Capital (hereinafter "**Riyad Capital**", "**we**", "**us**") needs your consent to collect certain data, including personal data, ("**Data**") regarding [the use of Riyad Capital services and products].

# 1. Purposes and means of processing and relevant data categories:

Subject to your consent, we collect and further process the following Personal Data for the purposes of [Riyad Capital services and products. The personal data we collect from you is mandatory to fulfil this purpose].

Education and employment information	Education level, Employment, name of employer, Date of Joining, Level, Son / Daughter / Wife DOB and names
Data collected as part of our interactions with you / Audio recordings	Comments, suggestions, needs, any records of phone calls, discussion by email, WhatsApp, live chat, exchanges on our pages on the social networks
Data from the video protection system	Including video surveillance cameras
Data concerning your devices	IP address, technical characteristics, and unique identification data
Legal and regulatory requirements	Information required by Riyad Capital for anti-money laundering in form of Know Your Customer (KYC) and Anti- Money Laundering (AML)
Cookie Information	Login information, Language settings, Website layout choices, pages visited, Time spent on the site, and clicks.
Health Data	Required heath data will be collected and maintained for some insurance contracts
Marketing	Details of any marketing preferences received from the customer

2. Except for certain information required by law, your decision to provide any personal data to us is voluntary. You will therefore not be subject to adverse consequences if you do not provide personal data. However, please note that if you do not provide certain information, we may not be able to accomplish some or all of the purposes outlined in this notice, and you may not be able to [obtain the services required by you] where it requires the use of such personal data.

# 3. Will we share your personal data with outside parties?

Your personal data may be shared with third parties.

We may transfer personal data to our service providers, professional advisors, public and governmental authorities or third parties in connection with a (potential) corporate or commercial transaction. Such third parties may be located in other countries. Before we do so, we shall take the necessary steps to ensure that your personal data will be given adequate protection as required by relevant data privacy laws and Riyad Capital's internal policies.

## 4. The voluntary nature and right of withdrawal

The provision of this consent and any of the Personal Data mentioned under No. 1. is voluntary/required for the specified purpose. However, if you do not consent, you will not be able to participate the required services and products

You have the right to withdraw your consent at any time, e.g., by sending us at *Link to be provided*. The withdrawal of consent does not affect the lawfulness of processing based on consent before its withdrawal.

#### 6. How long do we retain your personal data?

- We retain your personal data as long as we have an ongoing relationship with you.
- We retain your personal data where we are required to do so by a legal obligation to Which we are subject.
- We retain your personal data where this is advisable to safeguard or improve our legal position (for instance in relation to statutes of limitations, litigation, or regulatory investigations).

## 7. Your rights

You are entitled (in the circumstances and under the conditions, and subject to the exceptions, set out in applicable law) to:

- Request access to your personal data: this right entitles you to know whether we hold personal data about you and, if we do, to have access to that personal data.
- Request rectification of your personal data: this right entitles you to request your personal data to be corrected or completed if it is inaccurate or incomplete.
- Request erasure of your personal data: this right entitles you to request the erasure of your personal data, including where such personal data would no longer be necessary to achieve the purposes.
- Object to the processing of your personal data: this right entitles you to request that Riyad Capital no longer processes your personal data.
- Request the restriction of the processing of your personal data; this right entitles you to request that Riyad Capital only processes your personal data in limited circumstances, including with your consent.
- Request a copy or the portability of your personal data: this right entitles you to receive a copy of personal data that you have provided to Riyad Capital.
