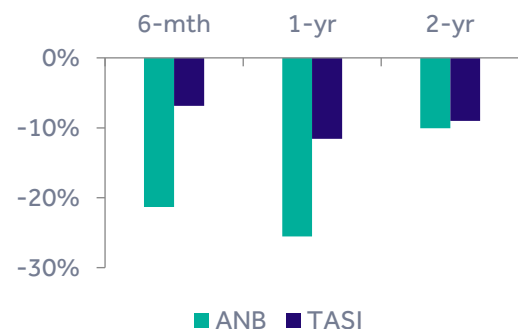

- Net loans decreased by SAR 2.8 bln, moreover, deposits continued their reduction for the second quarter dropping by SAR 2.1 bln. As a result, LDR slid from 87% last quarter to 86%.
- NSCI fell by -17% Y/Y and -7% Q/Q to reach SAR 1.2 bln, matching our estimates, (due to a drop in Special Commission Income by -23% Y/Y and -15% Q/Q). Non-core income of SAR 271 mln decreased by -9% Y/Y but was up by +36% Q/Q.
- Operating expenses rose by +23% Y/Y and +21% Q/Q to reach SAR 0.9 bln, primarily due to higher provisions (+62% Y/Y and +175% Q/Q) and rent expenses, which were offset by a decline in salaries, depreciation and other G&A expenses.
- Net income at SAR 486 mln, came in close to our SAR 530 mln estimate but missed market consensus of SAR 580 mln. We reduce our target price from SAR 21.00 to SAR 19.00 but maintain Neutral.
